AFFIDAVIT IN SUPPORT OF PROBABLE CAUSE
RE: PROBATION VIOLATION

Date: February 11, 2026

(To be used when a probationer is arrested for a violation of probation and is not released from custody or afforded a revocation hearing within five (5) days of arrest, excluding Saturdays, Sundays, and holidays.)

I, Sam Payson, a State of Maine Probation Officer, do hereby swear that I have probable cause to believe that Eliot Raphael Cutler (07/29/1946), a person who is currently on probation pursuant to sentence from HANCOCK CRIMINAL DOCKET, Docket#CR-2022-00241, has violated probation.

My basis for probable cause is:

On 2-09-26 members of the State Police Special Victims Unit were in Cumberland County conducting search warrants in the area. The members had reserved rooms at the Double Tree Hotel and were returning for the day.

Agent Jason Bosco who is a member of the SVU was walking through the parking lot to his room and saw Eliot Cutler who he knows for previous encounters. Agent Bosco spoke with Cutler and he noticed that Cutler had a bag in his hands and quickly placed the bag behind his back in an attempt to conceal it.

Bosco knew that Cutler was on probation and was subject to search. Cutler told Agent Bosco that he was in possession of pornography and begged him to not do anything. Bosco searched the bag that Cutler had and found wrappings, DVD cases that depicted nude images of adults engaging in sex acts.

Bosco contacted this PPO, I requested that Cutler be taken into custody and have officers search his room and vehicle for any more prohibited items. The agents took Cutler to his room where they found more pornographic dvd's and a new portable DVD player that was plugged into the hotel's TV. The officers then took Cutler to the Cumberland County Jail where I authorized a probation hold.

Attached are supporting documents, which I swear are true and correct to the best of my information and belief.

On 02/09/2026 I and other members of the State Police Special Victims Unit were conducting search warrant executions in Cumberland County. During the course of this operation our members had reserved rooms at a local hotel. At the conclusion of the day's operation several of our members, including myself, arrived at the hotel. As I was walking into the hotel I observed an older male whom I recognized from previous incidents to be Eliot Cutler. I spoke with Cutler briefly, identifying myself as State Police, and continued walking. Be advised that I did not pay attention to anything Cutler was holding at this time.

As Cutler continued walking another member of the State Police Special Victims Unit, Agent Jason Bosco, also recognized Cutler, confronted him and observed Cutler quickly place something behind his back, in an attempt to conceal. At this time Agent Bosco, knowing he was on state Probation, detained him. Cutler pleaded for Agent Bosco to not do anything. Cutler told Agent Bosco that he was in possession of pornography, that the item he was attempting to conceal was trash from that pornography that he was in the process of destroying. I arrived at this time.

Agent Bosco spoke with Probation Officer Sam Payson. PO Payson requested a search of Cutler's person, hotel room and vehicle, in the presence of Cutler. I searched the bag that Cutler was concealing and found it to be the covers to dvd containers, detailing various nude images of adults engaged in sex acts. Cutler himself was holding several empty dvd containers that had both the dvd and the covers removed. PO Payson advised that Cutler was not allowed to possess any pornography at all. PO Payson authorized a hold of Cutler under the offense of a probation violation. I placed Cutler in handcuffs behind his back, checking for proper tightness and locking to avoid any tightening.

I along with other SVU members escorted Cutler to his hotel room to which he possessed a room key. We entered the room, finding no one else present. All items found in the room were presumed to belong to Cutler alone. We located numerous pornography dvds which displayed various explicit titles and images of adult women. A small and new dvd player was hooked up to the hotel room television. In searching Cutler's pockets I found a receipt for the purchase of the dvd player from Walmart. I observed the box in which the dvd player had been packaged in along with the packaging contents.

Agent Bosco seized these and other items of evidence per PO Payson's request and per Cutler's probation conditions. Agent Bosco and I then escorted Cutler outside to his parked Chevrolet Tahoe, ME PC 760JNB. I unlocked the Tahoe with the keys found on Cutler's person. Agent Bosco and I searched the vehicle, finding no further evidence.

At this point I transported Cutler to the Cumberland County Jail. Cutler was charged with a Probation Violation as well as Violation of Conditions of Release (Class E). Cutler had three sets of active bail conditions that mandated that he abide by the conditions set forth in his probation.

On February 9, 2026, I and other members of the Maine State Police Special Victims Unit were conducting search warrant executions in Cumberland County. At the end of my day I arrived at the Double Tree hotel in South Portland. As I was gathering my belongings I observed an older male whom I recognized to be Eliot Cutler. As Mr. Cutler was walking towards me from the hotel I could see he was carrying a brown paper bag and a stack of black DVD cases in his right hand. I stepped up on the sidewalk from my car and said how are you Mr. Cutler of which he responded good and who are you. I said I was Jason Bosco from the Maine State Police. After I said this, Mr. Cutler then moved the bag and DVD cases behind his back. I asked Mr. Cutler if he was still on probation and he said he was. I asked who his probation officer was and he said Sam Payson. I asked Mr. Cutler if he was subject to search and he said he didn't think so. I said well what would PO Payson have to say about that and asked him what he was hiding behind his back. Mr. Cutler said nothing, I don't have anything. I said, my guess is that its something you are not supposed to have. Mr. Cutler then started to weep and said yes I messed up, please don't do this please don't do this. I asked what he had and he finally showed me and said he bought some pornography on DVDs. Mr. Cutler began to loudly cry and say he cant help himself and that he has had this problem for 65 years. I asked Mr. Cutler to set his things on my car and to have a seat on the hood. I asked Mr. Cutler if he had anything else or if he had anything in his room. Mr. Cutler said he had more DVDs in his room. I then called Sgt. Bagley and asked if he could come outside to help me out.

Sgt. Bagley arrived and I asked if he had Sam Payson's contact info which he did. I called and spoke with PO Payson and explained the above situation. PO Payson explained Mr. Cutlers conditions and said that he would be putting a hold on him. PO Payson then asked that we search his room and asked that Mr. Cutler be present during the search.

Mr. Cutler cooperated with this process and gave me his room key. Mr. Cutler came up to his room where Sgt. Bagley, Sgt. Joshua Lander, Cpl, Chris Smith and his K9 Doc and I went into Room #706 to search. While searching we found 10 adult pornographic DVD's and a DVD player that was connected to the hotel TV. I photographed the items and collected them as evidence.

Sgt. Bagley then transported Mr. Cutler to jail.

Special Conditions of Probation, as follows:

A. Defendant shall not possess "sexually explicit materials" as defined by Title 17-A (see e.g. Section 258 (2)), whether originating or generated on or off the internet

B. Defendant shall not possess any "photographs" as defined by Title 17-A M.R.S. Sec. 281 (3), or any other image or video material depicting "sexually explicit materials" or "sexually explicit conduct" defined by 17-A M.R.S. -or which depict unclothed minor children whether or not engaged in obscene or sexually explicit conduct

C. 
