With 6 Years Probation

It is now reported by <u>Sam Payson</u> representing Community Corrections, that there is probable cause to believe that the said <u>Eliot Raphael Cutler</u> has violated the terms of probation in the following manner:

1. On 9-08-25 in the Town of Brooklin you did violate your probation by failing to immediately notify your Probation Officer that you accessed an internet website that contained sexually explicit materials. (condition I)

2. On 9-08-25 in the Town of Brooklin you did violate your probation by accessing a website that displayed sexually explicit materials, obscene or sexually explicit conduct. (condition H)

3. On 10-02-25 in the Town of Brooklin you did violate your probation by possessing and using an electronic device (cell phones, an external USB drive) to connect to the internet that were not monitored as required by court ordered conditions. (condition C)

AFFIDAVIT IN SUPPORT OF PROBABLE CAUSE RE: PROBATION VIOLATION

Date: November 17, 2025

(To be used when a probationer is arrested for a violation of probation and is not released from custody or afforded a revocation hearing within five (5) days of arrest, excluding Saturdays, Sundays, and holidays.)

I, <u>Sam Payson</u>, a State of Maine Probation Officer, do hereby swear that I have probable cause to believe that <u>Eliot Raphael Cutler (07/29/1946)</u>, a person who is currently on probation pursuant to sentence from **HANCOCK CRIMINAL DOCKET**, Docket#<u>CR-2022-00241</u>, has violated probation.

My basis for probable cause is:

On 9-08-25 this officer received an email from RAN Customized Training and Consulting Inc. They monitor all of Cutlers registered electronic devices, in accordance with his court ordered probation conditions. It was reported that Cutler used an external USB drive to access content regarding massage parlors in the San Francisco area. The website he accessed contained a menu asking him what he would prefer sexually in an escort. Some questions he answered were reference the appearance of the escort for example he appeared to request an Asian female between the ages of 21 -25, with straight brown hair below her shoulders with no piercings, her "pussy" be shaved and "perky breast". This coincided with a request from Cutler for a travel permit to go to California to see elderly friends.

Your court ordered conditions prohibit you from accessing any internet websites known to depict persons engaging in sexual acts or sexually explicit conduct, or depicts sexually explicit materials, obscene or sexually explicit conduct. You also failed to immediately advise your probation officer that you had in fact accessed such a website.

On 10-02-25 while reporting to your PPO you met with PPO Robert Cartier, at that time you turned over two cell phones that were not being monitored by RAN per your conditions. I delivered the phones to the Maine State Computer Crimes Unit in Vassalboro. On 10-15-25 I received an email from the CCU stating that they found nothing on the phones of note but also the phones had been reset.

Attached are supporting documents, which I swear are true and correct to the best of my information and belief.
